PETITION FOR FAVOR OF THE FAITH - PAULINE PRIVILEGE

<u>The Pauline Privilege</u> - In 1 Cor 7:12-13, 15 St. Paul was faced with a problem caused in marriages where one spouse converted and became a believer in Christ and the other spouse did not believe. If the non-believer was willing to live in peace with the believer, the marriage was to remain intact. However, if the non-believer was not willing to live in peace with the believer and subsequently departed from the marriage, St. Paul states that the believer was not bound to the duties and obligations of the marriage. Over time this pastoral solution developed into what is known as the Pauline privilege.

<u>Conditions for Application</u> - Before the Pauline privilege can be applied, the following three criteria must be satisfied:

- 1. a marriage entered into by two non-baptized persons;
- 2. the subsequent baptism of one and only one of the spouses during the course of the marriage; and
- 3. the departure of the still non-baptized spouse.

It is the responsibility of the diocesan bishop to verify that these conditions have been met. On a practical level, before this privilege is applied, it has to be determined that:

- there is no possibility of restoring conjugal life.
- the petitioner was not the primary cause of the breakdown of the conjugal relationship.
- the petitioner's current or intended spouse did not provoke the breakdown of the conjugal relationship.
- the petitioner has fulfilled his/her moral and civil obligations toward the first spouse and offspring.
